Intellectual Property Rights and Confidentiality Agreement

Small But Perfect Consortium Partners are committed to protect the confidentiality and IP rights of all submitted information of applicants during any stage of the submission, selection process and during the acceleration process

Article 1 - Confidentiality

All parties and their employees and partners must maintain confidentiality regarding any information of public or private interest they receive as a result of their relationship with the project.

Any confidential and sensitive information, information, reports and any other information directly or indirectly related to the activity of the project, which has become known to the parties or one of their employees, or from external consultants acquired by the parties in the exercise of their powers, shall be deemed to be confidential information. The parties shall always, both during and after the end of the project, maintain the confidentiality of such confidential information and shall abstain from any action to disclose it in any way in the interest of him or her or in the interest of any other person.

Any project, correspondence, specifications, violations, supplier lists, information of beneficiaries or companies or employers involved in the project, and any other documents, studies are confidential and confidential. Tools, systems, reports and assets made or prepared by the parties or placed in their possession or control over their work in the project or relating in any way to the public, local government, beneficial undertakings or beneficiaries of refugees, victims of trafficking and must, together with all documents, be kept confidential.

All parties are obliged to respect with complete confidentiality information, data, records, works, logos, passwords, badges, personal data of other partners and its members that will be known to them during this cooperation.

Any element of personal data of beneficiaries who participate in any way directly or indirectly in the project is subject to strict confidentiality, likewise their photos, their personal identification information. Items can only be used after their written acceptance of the disposal of their photos and images. Female victims and children are protected from all and strict protection and confidentiality of their data, images, their voices and any other means that could arrange them outside the consent of guardians for minors and themselves for adults

Article 2 - Intellectual Property Rights

The intellectual property rights of the work of SBP belong to all parties who, with the agreement of all, should decide on their dissemination, exploitation and any other means or means of their exploitation. A Copyright Management Committee is set up involving representatives of all three bodies, all of which have
